Purpose

This workshop will inform various stakeholders of the Energy Commission's schedule and proposed funding areas for the EECBG and SEP programs, administered by the Energy Commission. The workshop will also offer stakeholders an opportunity to learn about the guideline development process for both programs.

Background

On June 3, 2009, the California Energy Commission adopted an order instituting an informational proceeding to gather information to develop guidelines that will govern the administration and award of federal funds received pursuant to ARRA.

ARRA provides \$787 billion nationally in economic investment to stimulate the economy and create jobs. The Energy Commission is administering two programs (and possibly more in the future), the EECBG for \$49.6 million and the SEP for \$226 million.

The guidelines will focus on the Energy Commission's implementation of the EECBG Program and the SEP and will describe program objectives, eligibility requirements and limitations, available funding, evaluation criteria, and administrative procedures to apply for funding.

The Energy Commission will develop the guidelines as part of a public process in coordination with the state's energy agencies, local governments, utilities, interested stakeholders, and members of the public. To the extent possible, the guidelines will be developed on an expedited basis consistent with the purposes of ARRA and Governor Schwarzenegger's Executive Order S-02-09, which created the Federal Economic Stimulus Task Force.

The order establishes an ad hoc committee to preside over the proceeding. The Committee is referred to as the "Ad-Hoc Committee on the American Recovery and Reinvestment Act of 2009." Chairman Karen Douglas is the Presiding Member of the Committee and Commissioner Arthur H. Rosenfeld is the Associate Member.
