Pursuant to the Committee Scheduling Order dated August 10, 2009, the following is staff's Status Report #1 for the proposed Almond 2 Power Plant project.

Staff Data Requests

On August 13, 2009 staff issued data requests (#s 1-84) in the following technical areas: Air Quality (#s 1-15), Cultural Resources (#s 16-24), Hazardous Materials Management (#s 25-29), Public Health (#s 30-33), Soil and Water Resources (#s 34-69), Traffic and Transportation (#s 70-71), Transmission System Engineering (#s 72-74), Waste Management (#s 75-78) and Worker Safety and Fire Protection (#s 79-84). Written responses to the data requests are due to the Energy Commission staff on or before September 11, 2009, or such later date as may be mutually agreeable.

Data Response and Issues Resolution Workshop

Staff and the applicant have scheduled a Data Response and Issues Resolution Workshop for Tuesday, September 22, 2009 at the Energy Commission's Conference Room 3 North E at 10:00 am. which will be noticed separately.

Current Issues

At this time, staff has not identified any additional issues which may delay the project. However, staff anticipates possible delays due to the heavy workload in the Siting, Transmission and Environmental Protection Division, and also due to the Governor's Executive Order S-13-09, mandating three furlough days a month for the Commission and most other state agencies through June 2010.
