## Subject: CPV VACA STATION PROJECT (08-AFC-11) STATUS REPORT 5

Staff submits the following Status Report for the proposed CPV Vaca Station Project (CPVVS), pursuant to the Committee Scheduling Order dated March 23, 2009.


#### **Current Issues and Activities for Resolution**

On July 31, 2009, staff received the applicant's responses to data requests set 3 (#68 -96), and is using the responses information to prepare the Preliminary Staff Assessment (PSA). On September 9, 2009 staff received the System Impact Study (SIS) prepared by Navigant Consulting for CPV Vacaville, LLC (CPVV). After reviewing the document, staff determined that additional information is needed to fully analyze the project's proposed transmission lines, and has asked CPVV for the California Independent System Operator Transition Cluster Phase I Interconnection Study Report. This information is needed by staff in order to complete the transmission system section of the PSA.

On September 30<sup>th</sup>, CPVV requested its fourth extension (one-month) to accommodate receipt of the preliminary determination of compliance (PDOC) that is being prepared by the Yolo-Solano Air Quality Management District (YSAQMD). Staff needs the PDOC in order to fully assess the proposed air quality offset emissions of the project, to evaluate the applicant's proposed mitigation package and to complete the air quality preliminary staff assessment. CPVV has also revised its initial offset plan which relied on the use of volatile organic compounds (VOC) offsets in lieu of nitrogen dioxide (NO<sub>x</sub>) offsets to meet the YSAQMD's offset requirements. As a result of the modified offset plant, both the U.S. Environmental Protection Agency and YSAQMD are requesting additional information regarding the interpollutant offset trade ratio.

#### <u>Schedule</u>

The following PSA sections are still outstanding: biology, cultural resources, land use, waste management, traffic and transportation, cultural resources, transmission system design, visual resources, and soils and water resources, which staff hopes to complete by the week of October 26<sup>th</sup>. Given this scenario, coupled with staff's heavy workload and furloughs, early November is a realistic date for publishing the PSA if staff receives the PDOC by mid-October. Staff is now working towards the following schedule for the CPVV Project:
