Request to Amend Strategic Investment Plan:

Gentleman:

Please find this request from EWindfarm, Inc. (EWind) to CEC to amend the above Plan as follows;

- Add 2x500kV line from Kramer to Control to Nevada Energy Corridor (see Figures A-C)

The above line is requested because of the following considerations;

- There is a shortfall of renewable energy projects in California to meet its renewable energy goals
- Implementation of this new line will enable California to take advantage of untapped geothermal and wind and solar resources in Mono and Inyo Counties and neighboring Nevada counties
- This transmission line path is the weakest path to the largest load center in California
- There exist transmission line right of ways in the proposed new path which could be expanded for the proposed new 2x500kV line lines including LADWP and SCE and Terra-Gen right-of-ways
- Proposed new 2x500kV line compliments the DOE and Nevada Energy Corridors

- Other benefits to California

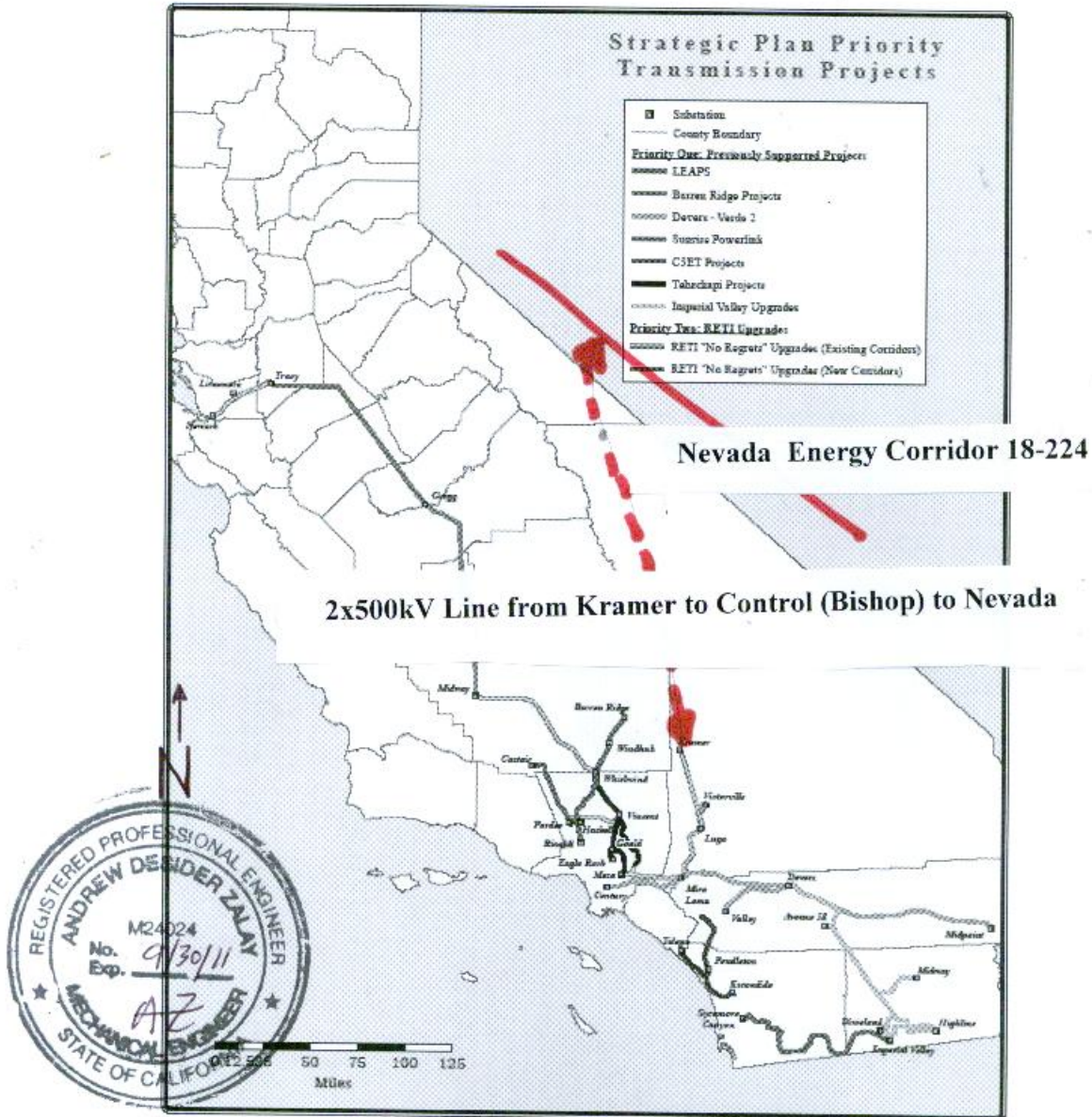

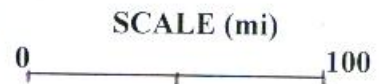
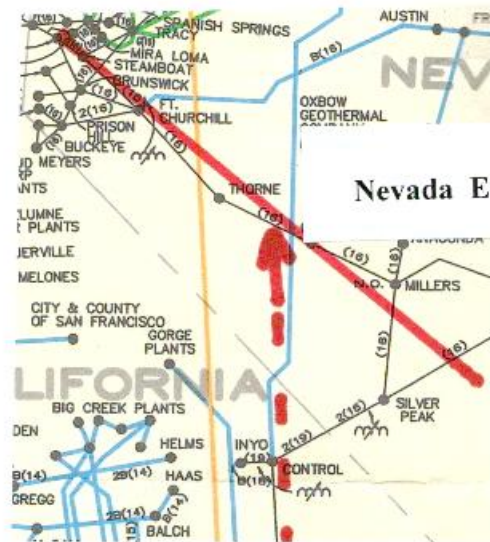
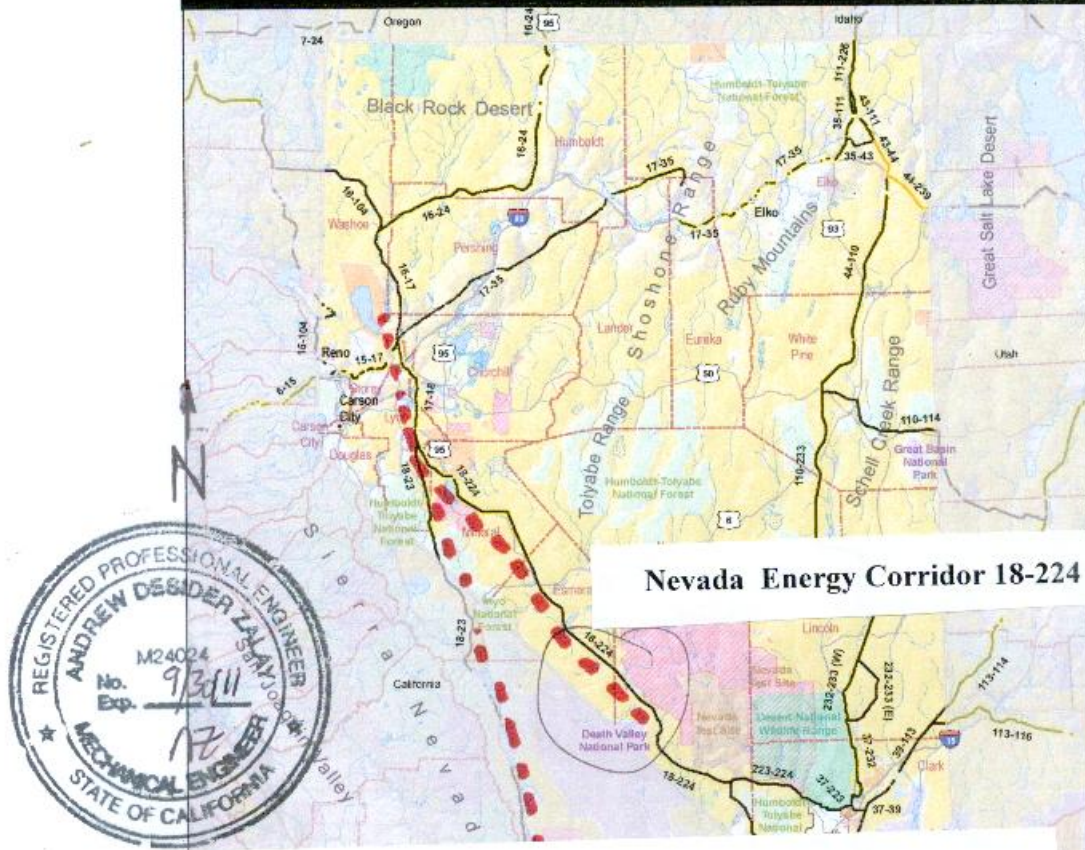


Figure B – Request for Amended Strategic Plan: WECC Overlay

2x500kV Line from Kramer to Control (Bishop) to Nevada

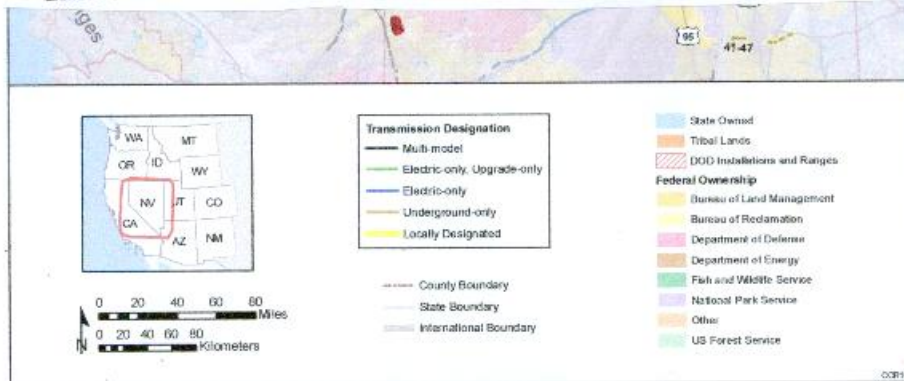


Figure C – Request for Amended Strategic Plan: Nevada Energy Corridor Overlay
