COMMITTEE ORDER GRANTING MOTION FOR STATUS CONFERENCE AND SCHEDULE CHANGES

I. SUMMARY

On November 17, 2009, Applicant, Beacon Solar, LLC, filed a Motion for New Schedule (Motion). The Motion requests the Committee to vacate the schedule for the Prehearing Conference and Evidentiary Hearings scheduled for December 1, 7, 8, and 9, 2009, respectively. Applicant also moves the Committee to vacate the November 19 and 23, 2009 filing dates for rebuttal testimony and Prehearing Conference Statement. Instead, Beacon requests that the Committee hold a Status Conference in place of the Prehearing Conference scheduled for December 1, 2009. At the Status Conference, Beacon seeks to discuss a refined water plan with the Committee, Staff, California Unions for Reliable Energy and the public.

II. ORDER

Good cause appearing, Applicant's Motion is **GRANTED**. The Committee vacates the December 1, 2009 Prehearing Conference, and the December 7, 8 and 9, 2009 Evidentiary Hearings. The Committee further vacates the scheduled filing of rebuttal testimony and prehearing conference statements which were due November 19 and 23, 2009, respectively. The parties are ordered to come to the Status Conference prepared to discuss and propose a revised schedule.
