

Background

On November 17, 2009, Applicant, Beacon Solar, LLC, filed a Motion requesting the Committee to vacate the previously ordered Prehearing Conference and Evidentiary Hearings, and the filing dates for rebuttal testimony and the Prehearing Conference statements. Further, Beacon Solar requested the Committee to conduct a Status Conference in place of the Prehearing Conference that had been previously scheduled for December 1, 2009.

On November 18, 2009, the Committee GRANTED the Motion and Ordered the Status Conference to take place on December 1, 2009. The Committee further Ordered the parties to come to the Status Conference prepared to discuss and propose a revised schedule.

Purpose of the Status Conference

This Status Conference was calendared at the request of Beacon Solar to discuss a refined water plan with the Committee, Commission staff, California Unions for Reliable Energy and the public. At the Status Conference, parties will inform and advise the

Committee on producing a new Scheduling Order that accurately reflects the project's current status.
