The California Energy Commission proposes to adopt Guidelines for Certification of Combined Heat and Power Systems (Guidelines) according to the Waste Heat and Carbon Emissions Reduction Act (the Act), Public Utilities Code, Section 2840, et seq. as enacted in AB 1613 (Blakeslee, Chapter 713, Statutes of 2007) and amended in AB 2791 (Blakeslee, Chapter 253, Statutes of 2008). These Guidelines are exempt from the requirements of the California Administrative Procedures Act, beginning with section 11340 of the Government Code. Public Utilities Code section 2843(c) is the controlling procedures for the adoption of these Guidelines.

The Energy Commission has prepared this Notice of Proposed Action (NOPA), a Statement of Reasons as part of the supporting documents to adopt the proposed amendments. The Energy Commission has also published the Express Terms of the proposed Guidelines. COMMITTEE DELEGATION AND AUTHORIZATION

The Electricity and Natural Gas Committee (consisting of Presiding Member Commissioner Jeffrey D. Byron and Associate Member Commissioner James D. Boyd) or a successor Committee with similar powers and duties appointed under Public Resources Code Section 25211 presided over this proceeding. The Committee, on behalf of the Commission, has authority to take all actions necessary and appropriate to comply with all applicable legal requirements, including but not necessarily limited to the Warren-Alquist Act, the Waste Heat and Carbon Reduction Act, and the California Environmental Quality Act.

The Committee is authorized to work collaboratively with the Public Utilities Commission and the Air Resources Board to ensure implementation of the Act in a manner consistent with its legislative purpose. Any and all decisions, policies, guidelines, rules or regulations proposed by the Committee in this rulemaking shall become final when formally adopted by the Commission at a business meeting.

AUTHORITY AND REFERENCE

The Energy Commission proposes to adopt the Guidelines for Certification of Combined Heat and Power Systems under the authority of Public Utilities Code section 2843.

AVAILABILITY OF MODIFIED AMENDMENTS

At the January 13, 2010, adoption hearing, the Energy Commission may adopt the proposed Guidelines. If modifications are made and they are sufficiently related to the originally proposed Guidelines, the full modified text with changes clearly indicated will be made available to the public at least 10 days before the Energy Commission adopts the Guidelines. A notice of availability of any such text will be placed on the Energy Commission's website and will be mailed to all persons to whom this notice is being mailed, as well as to all persons who submitted written or oral comments at workshops. In addition, copies may be requested from the contact person named in the NOPA and from the Docket Office. The Energy Commission will accept written comments on any

such modified text for at least 10 days after the text is made available to the public. Adoption of the modified Guidelines will be considered at this public hearing scheduled on January 13, 2010, or a subsequent noticed public hearing.
