

# Subject: Selection of Cultural Resources Evaluation Approach Solar Millennium for Blythe Solar Power Project (09-AFC-6)

Dear Mr. Solomon:

Solar Millennium has reviewed your letter dated December 1, 2009 in which you outlined three methods the BLM and the CEC Staff have developed to evaluate and assess the potential effects of projects on possible cultural resources. In your letter you outlined three approaches but concede that it may be very difficult for the BLM and CEC Staff to implement the first two options in time for the Blythe Solar Power Project (BSPP) to obtain authorization in time to receive stimulus funds under the American Recovery and Reinvestment Act (ARRA) funds. The third approach is new and will allow the BLM and CEC Staff to complete assessment of the project in time for ARRA funds.

As outlined in your letter, although the third approach allows the assessment to be completed in time, there is considerable risk that selection of this option may cause delays during construction and mitigation and monitoring costs to be significantly greater than the first two approaches. Solar Millennium elects BLM and CEC Staff's new approach outlined in the third option in order to facilitate preparation of the assessment in time for ARRA funds. In order to mitigate the potential for delays during construction, Solar Millennium will work with Staff to develop the terms of the Memorandum of Agreement (MOA) and appropriate treatment plans prior to construction. Solar Millennium understands that Staff will assist in developing such plans prior to a Decision on the project.
