

## **COMMITTEE ORDER GRANTING PETITION TO INTERVENE**

**3:00 p.m. on January 11, 2010.** The Issues Identification Report must contain "Docket No. 07-AFC-3" in the caption or heading.

Further, the Executive Director or her designee shall ensure that Petitioner is immediately provided with a copy of the Application for Certification (AFC). The Intervenor is advised that discovery is closed.
