Proposed Changes to SES Solar Two and Calico Solar (formerly Solar One)

**Schedules** 

During the January 27, 2010 Status Conference on the Calico (Solar One) project, it became clear that the release date for the Staff Assessment/Draft Environmental Impact Assessment (SA/DEIS) was going to be delay about a month to March 15. We have also learned recently that date that the SA/DEIS for the Imperial Valley (Solar Two) project would also slip from January 2, 2010 to approximately February 12, 2010. While we regret the delays, we understand them given the significant workload facing the Commission staff and the complexities of working with multiple agencies on projects. As we stated in our comments at the Renewable Energy Policy Group meeting on January 22, 2010 and at the Status Conference, we would prefer that the Commission staff release an adequate and defensible SA/DEIS rather than focus on a strict publication date at this point in the proceedings. It is critical to us, however, that the decision date outlined in both Committee schedules be met so that we can undertake desert tortoise relocation work on Calico (Solar One) and begin construction of both projects in order to meet the ARRA requirements.

We have looked closely at the schedules for both the Imperial Valley (Solar Two) and Calico (Solar One) projects and believe the final decision dates can be met even with the slippage of the SA/DEIS identified above. To accomplish this, four actions would be required:

- 1. Early initiation of workshops and hearings in both projects as contemplated in the Committee's schedule on Calico (Solar One)
- 2. Reducing the time for post hearing briefs from three weeks to two weeks
- 3. Requesting the US Fish and Wildlife Service to comply with the 90-day preparation of a Biological Opinion as agreed in their MOU with the BLM
- 4. Publication of the Supplemental Staff Assessment/Final Environmental Impact Statement four weeks following the close of the SA/DEIS comment period and receipt of the Biological Opinion.

The first attached page compares the current Imperial Valley (Solar Two) and Calico (Solar One) schedules and the lapsed time between major events. It also identifies a single, consistent schedule of events that can be used for both cases. The second attached page presents a proposed schedule for both Imperial Valley (Solar Two) and Calico (Solar One) assuming this consistent schedule of events. These schedules allow the slippage in filing the SA/DEIS and meeting the necessary decision dates for both projects.
