



This Repeated Application for Confidential Designation covers additional cultural resource information (CHRIS Information) titled here as (Cultural Resources) Alternatives Assessment for the Proposed Blythe Solar Power Project, Volumes II through X. This additional information is substantially similar and related to the cultural resource information supplied to the CEC on September 24, 2009 for the Blythe Solar Power Project, which was granted confidential designation by the Executive Director.
