

Dear Ms. Jones,

Solar Millennium LLC, as an owner of the Palen Solar Power Project (PSPP) requests that the attached information be designated confidential pursuant to 20 CCR Section 2505. This information is being supplied to the California Energy Commission (CEC) as Confidential Cultural Resource Class I Results for the PSPP Alternatives in response to Data Request 121(a) through (d); specifically related to the Cibola Alternative, Palo Verde Alternative, Desert Center Alternative and Updated Palen Pass Alternative (being described in detail below).

In support of its application for confidentiality designation, Solar Millennium LLC, provides the following information:

This additional information is substantially similar and related to the cultural resource information supplied to the CEC on January 13, 2010 for the Palen Solar Power Project, which was granted (or pending) confidential designation by the Executive Director. As previously noted, this information is being submitted under 20 CCR 2505(a)(4) which states in pertinent part,

"[a]n applicant... seeking a confidential designation for information that is substantially similar to information... for which an application for confidential designation was granted by the Executive Director pursuant to subdivision (a)(3)(A) of this section, the new application need contain only a certification, executed under penalty of perjury, stating that the information submitted is substantially similar to the previously submitted information and that all the facts and circumstances relevant to confidentiality remain unchanged."

I certify under penalty of perjury that the information contained in this Repeated Application for Confidential Designation is substantially similar to the previously submitted cultural resource information and that all of the facts and circumstances relevant to confidentiality remain unchanged.
