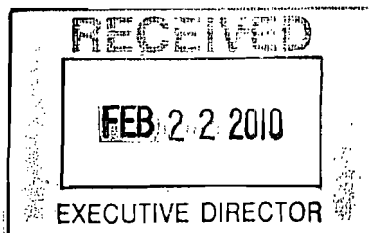

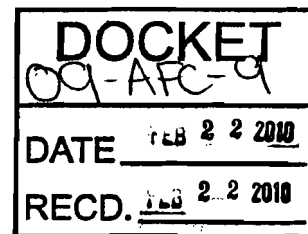

Solar Millennium LLC, as an owner of the Ridgecrest Solar Power Project (RSPP) requests that the attached information be designated confidential pursuant to 20 CCR Section 2505. The following information is being supplied to the California Energy Commission (CEC) in response to Staff Data Requests.

On 9/16/09 the Applicant filed an original request for Confidentiality for Cultural Resource Information as part of its original Application for Certification (AFC). The Executive Director granted Confidentiality for the original submittal on October 23, 2009. This additional information is substantially similar and related to the original request. As previously noted, this information is being submitted under 20 CCR 2505(a)(4) which states in pertinent part,

*"[a]n applicant... seeking a confidential designation for information that is substantially similar to information... for which an application for confidential designation was granted by the Executive Director pursuant to subdivision (a)(3)(A) of this section, the new application need contain only a certification, executed under penalty of perjury, stating that the information submitted is substantially similar to the previously submitted information and that all the facts and circumstances relevant to confidentiality remain unchanged."*
