

Pursuant to Title 20 California Code of Regulations section 2505(a)(4), Covanta Mendota L.P. hereby submits this Repeated Application for Confidential Designation for the following information:

- CEC-1250E-1 Application for ERFP Funding Eligibility and all supporting attachments and materials. Specific lines and responses:
