Project Description: Construction and operation of a 200MW, natural gas-fired, simple cycle power plant, consisting of four 50MW combustion-turbine, electric generators. On March 17, 2010, the California Energy Commission approved the above-described project pursuant to a regulatory program certified by the California Secretary of Resources under Section 21080.5 of the California Public Resources Code.

1. The project will not have a significant effect on the environment.
2. Mitigation measures were made a condition of approval of the project.
3. A statement of Overriding Considerations was not adopted for the project.


