Pursuant to the Committee Scheduling Order dated October 30, 2009, the following is staff's Status Report #4 for the proposed Mariposa Energy Project (MEP). This is an update for activities that have occurred since the previous Status Report on March 4, 2010.

Data Requests

Staff issued data request Set 2 A on March 4, 2010. These data requests were in regard to the Williamson Act Contract on the property, the lease between Diamond Generation and the property owner and exceptions in the title report.

Supplement B – Additional Laydown Area Analysis

The Applicant provided Supplement B – Additional Laydown Area Analysis on March 5, 2010. Mariposa Energy prepared this supplement to provide Energy Commission staff with a detailed environmental analysis of an additional 4.2 acres of laydown area adjacent to the MEP site. This additional area includes the space directly between the MEP site and the original proposed laydown area, as well as a slight extension to the north.

Outstanding Data Responses

The applicant has indicated that a Data Response packet will be provided on April 1, 2010 that includes clarification of data responses for transmission system engineering and responses to comments from the Contra Costa County Airport Land Use Commission; Keith Freitas - Contra Costa County Director of Airports and Hal Yeager - Contra Costa County Airport Land Use Commissioner.

Staff needs these data responses prior to completion of the Preliminary Staff Assessment (PSA).

Bay Area Air Quality Management District

The applicant is working with the Bay Area Air Quality Management District (BAAQMD) to ensure that an application to the district is accepted as complete and is being reviewed. The applicant provided the BAAQMD with additional dispersion modeling for nitrogen dioxide on March 16, 2010.

The air district has indicated that they are still working with the applicant on carbon monoxide standards for the project. Until the applicant and air district reach an agreement on appropriate standards, the information to prepare the Preliminary Determination of Compliance (PDOC) is not complete and the PDOC cannot be prepared.

The air district has not identified when the PDOC will be completed. The delay of the PDOC is creating a delay in the preparation of the Air Quality section of the PSA.

Project Schedule

The project schedule is dependent upon the applicant providing complete data responses and the PDOC being issued by the air district. Staff is unable to commit to a schedule at this time without assurances on when the PDOC will be issued. Once staff, knows when the PDOC will be issued, we will propose a modified schedule.

Staff will continue to keep the Committee apprised of current work products and critical timelines, and a project status report will be prepared for May 1, 2010.
