Project Title: Adoption of Revisions to the *State Energy Efficient Appliance Rebate Program Guidelines*.

Description of Nature, Purpose, and Beneficiaries of Project: The purpose of this activity is to revise *Guidelines* previously adopted by the California Energy Commission to govern the administration of its State Energy Efficient Appliance Rebate Program pursuant to Public Resources Code Sections 25460 - 25463. The *Guidelines* describe how the Energy Commission will implement its State Energy Efficient Appliance Rebate Program and identify available funding, eligibility criteria, and procedural requirements to qualify for program funding. The *Guidelines* were revised to adjust the rebate level for specified appliances, adjust the expected start date of the program, adjust the eligibility date for qualifying appliances, and to make other minor clarifying changes to better administer the program. The California Energy Commission and participants of the State Energy Efficient Appliance Rebate Program benefit from the adoption of revisions to these *Guidelines*.
