



Please be advised that the Energy Commission and Bureau of Land Management staff met at the Palen proposed site on April 8, 2010 with staff from the California Department of Fish and Game and the U.S. Fish and Wildlife Service. The purpose for this visit was to evaluate potential lands that could be added to the staff's reduced acreage alternative presented in the Palen Solar Power Project Staff Assessment/Draft Environmental Impact Statement (SA/DEIS).

With the goal of identifying a project configuration that both avoids the sensitive biological resources identified in the SA/DEIS and attains, as close as possible, the megawattage originally proposed, Energy Commission staff have identified an additional possible alternative configuration for the Palen Solar Power Project. I wanted to provide you with a copy of this alternative so that you and your staff have time to review it prior to the April 16, 2010 Workshop so that the parties can engage in meaningful dialogue concerning the technical feasibility of this alternative.


