As part of the May 12, 2010, Business Meeting, the Energy Commission will consider adopting revisions to the *California State Energy Efficient Appliance Rebate Program Guidelines* (*Guidelines*). These *Guidelines* were developed to help implement and administer rebates for qualifying appliances under the American Recovery and Reinvestment Act (ARRA) of 2009. The U.S. Department of Energy (DOE) has allocated to the Energy Commission \$35.2 million in ARRA funds to implement a State Energy Efficiency Appliance Rebate Program for California that will provide rebates to encourage the replacement of inefficient residential appliances with new energy efficient residential appliances. The *Guidelines* establish the eligibility and procedural

requirements to qualify for rebates for the purchase of eligible residential appliances. The *Guidelines* were originally adopted by the Energy Commission on December 16, 2009, and were subsequently amended on March 24, 2010.

At the direction of the Energy Commission's Ad Hoc Committee on Federal Stimulus Programs (Committee), proposed revisions have been made to the *Guidelines* to update the list of eligible appliance models that may qualify for rebates. Under the current *Guidelines*, only appliance models that have been shown to meet the appliance eligibility criteria by March 15, 2010 may qualify for rebates. Under the proposed revisions, the list of eligible appliance models will be updated on a weekly basis to include additional appliance models that have been shown to meet the eligibility criteria for the program. The weekly updates to the list of eligible appliance models will begin once the proposed revisions are adopted by the Energy Commission.

The March 15, 2010 eligibility date was originally selected to provide consumers, retailers, and manufacturers with certainty on the list of eligible appliance models, so that these program participants could gear up in anticipation of the April 22, 2010 program launch date. However, on April 21, 2010, the DOE released an updated list of appliance models that meet *Energy Star* rating standards. Many of the appliance models on this list may be able to meet the appliance eligibility criteria for the program. The proposed revisions to the *Guidelines* would allow the list of eligible appliance models to be expanded to provide program participants with more options to qualify for rebates.

The proposed revisions are made to Section 5.b. on page 4 of the *Guidelines* and are shown in Attachment 1 of this notice.

The Committee recommends that the proposed revisions be adopted by the Energy Commission.



- Benefits of recycling and availability of retailer exchanges/pick-up.
- Ability for replacement/early retirement of appliance to result in multiple and indirect benefits, including environmental benefits and energy savings.

### b. Appliance Eligibility Criteria

Appliance models that fall within the eligible appliance categories listed above (clothes washers, refrigerators, and room air conditions) must also meet the following criteria in order to be included in California's SEEARP:

- Must be listed on the ENERGY STAR® website<sup>1</sup>.
- Must be certified to the Energy Commission.
- Must comply with the efficiency criteria listed in Table 1, below.

Only those appliance models that have been shown to meet the specified program criteria with the submission of necessary information ~~by March 15, 2010 to the Energy Commission~~ will be qualified for a California SEEARP rebate within the rebate offer period. The official list of qualifying models for California's SEEARP will be published by the Energy Commission on March 18, 2010, and updated on a weekly basis starting May 12, 2010. <u>Appliance</u>	<u>Rebate</u>	<u>Energy Efficiency Criteria</u>
Clothes Washers	\$100	CEE Tier 2 or greater <sup>2</sup> - modified energy factor $\geq 2.0$ , water factor $\leq 6.0$
Refrigerators	\$200	CEE Tier 2 or greater <sup>3</sup> - efficiency levels 25 percent or more above the federal standard
Room Air Conditioners	\$50	No additional CEE criteria.
