

Data Request

SQ-4. On September 17, 2009, the City of Ceres responded via letter to the AFC review for the Almond 2 Power Plant. In the letter, the City identified a concern regarding placement of the transmission line along Crows Land Road. The City recommended that the transmission line be placed a minimum of 70 feet from centerline on Crows Landing Road so that these lines will not interfere with the development of Crows Landing Road. Please provide a discussion regarding this request.

Response: Attachment SQ4-1 provides an analysis of the future expansion of Crows Landing Road.

1.0 Introduction

This memorandum presents the findings of literature review and inquiries to Stanislaus County in response to a request to investigate planned improvements to Crows Landing Road, and its funding status.

2.0 Methodology

CH2M HILL reviewed the relevant land use planning documents for the A2PP site and project area, including the following primary documents:

- City of Ceres Service Road Master Plan
- City of Ceres General Plan Circulation Element
- West Ceres Specific Plan
- City of Ceres Major Project List Fiscal Year 2008/2009
- Stanislaus County General Plan Circulation Element
- Stanislaus County Regional Transportation Plan (RTP) 2007
- Stanislaus County Capital Improvement Plan 2009-2010

Since the proposed 115-kV line route is within the County of Stanislaus once the line leaves TID property and crosses over TID Lateral 2, the above research was supplemented with a phone call to Stanislaus County to confirm findings from the literature review, and to ascertain the current status of planned improvements to Crows Landing Road. The call focused on the A2PP transmission line route along Crows Landing Road.

I have also reviewed the letter from Brian S. Biering of Ellison, Schneider & Harris, to Felicia Miller of the CEC, dated, January 13, 2010.¹ I am not an attorney; however, I am informed, based on that memorandum and communications with counsel for TID, that TID is exempt from compliance with city and county building and zoning ordinances and general plan requirements for facilities that are connected and integral to the provision of water and energy services.

Notwithstanding that exemption, for the purposes of my review, I was directed to review these documents as if they were applicable LORS and did review them as if they were applicable LORS in my investigations.

3.0 Findings

Table 1 summarizes the findings from the documents reviewed.

	Keyes Rd (the A2PP area). Segments 2 -7, outside the project area, are classified as Category C out of a possible 4 categories (A through D). Category C is defined as "a future need, but not presented in detail to the Board".
	Construction is planned to begin on Segment 2 in 2012, and Segment 7 is estimated to begin in 2024.

CH2M HILL also contacted Stanislaus County² to determine the current status of planned improvements to Crows Landing Road, particularly because Segment 1 or the area north of Keyes Road on Crows Landing Road was referenced in the 2007 RTP but not included in the 2009-2010 Capital Improvement Plan.

The County confirmed that at the current time, no funding has been identified for Segment 1, and that all planned improvements to Crows Landing Road, including the proposed widening from Service Road (Segment 1) to SR 33 (Segments 2 through 7) and all signal improvements, have been delayed indefinitely for lack of funding. The County anticipates construction for the project beginning sometime after 2030. The proposed widening would involve widening Crows Landing Road to 6 lanes, in accordance with the County General Plan.

4.0 Conclusion

In summary, Stanislaus County and the City of Ceres would like to widen Crows Landing Road from Service Road to SR 33, but based on review of relevant documents and discussion with Stanislaus County, there are no reasonably foreseeable plans to improve this portion of Crows Landing Road within the near future. Implementation of improvements have been delayed indefinitely, and at this time, no funding sources been identified.
