

California's Cash for Appliances rebate program began on April 22, 2010, with a list of qualified models published in accordance with the Guidelines (Publication # CEC-400-2009-025-CMF-REV2) for the program. As part of the May 12, 2010, Business Meeting, the California Energy Commission will consider adopting revisions to the California State Energy Efficient Appliance Rebate Program Guidelines (Guidelines). These proposed revisions will allow updates to the list of eligible appliances in response to changes by the Department of Energy's to the list of Energy Star® Qualified appliances.

Models must meet three requirements in order to be eligible for the Cash for Appliances program:

- 1. Must be present on the ENERGY STAR website as an ENERGY STAR qualified model
- 2. Must be certified to the California Energy Commission in accordance with the Title 20 Appliance Efficiency Regulations and shown in the Appliance Efficiency Database
- 3. Must meet minimum design and efficiency requirements

Models that do not meet all three of these requirements cannot be added to the Qualified Model lists for the program. Additional information is available at the following locations:

For models that meet the minimum efficiency requirements and are already ENERGY STAR listed but have not been certified to the Energy Commission, you must submit a complete data certification packet to the California Energy Commission no later than May 10, 2010 to be included in the earliest revision of the Qualified Model lists. All outstanding or pending data submittals submitted to the Energy Commission regarding Clothes Washers, Refrigerators and Room Air Conditioners will be given processing priority. California Cash for Appliances rebates will only be awarded for products that were eligible for a rebate AT THE TIME OF PURCHASE.
