Dear Certified Appliance Recycler:

On April 22, 2010 (Earth Day 2010), the California Energy Commission will launch the California Cash for Appliances rebate program, one of state's largest residential consumer appliance recycling programs.

Recycling inefficient appliances through a Certified Appliance Recycler (C.A.R.) is required and key to the program's success. As a Certified Appliance Recycler your participation is essential and I invite you to become an "Official Partner" to assist with the thousands of appliances that must be recycled.

Rebates will be available for consumers who purchase select models of three appliance types: clothes washers, refrigerators, and room air conditioners. Recycling the old unit of the same type is required for consumers to qualify for a rebate. The Energy Commission expects a strong increase in the number of units delivered to C.A.R.s from individuals, retailers, and utility haul-away programs.

The California Energy Commission is sensitive to illegal dumping issues and we have implemented several measures that will ensure that the old units are ultimately delivered ONLY to Certified Appliance Recyclers.

As a C.A.R. "Official Partner" we are providing the attached example DRAFT recycling certificate as an example of the proof of recycling sought. This Recycling Certificate will require your C.A.R unique code provided by the California Department of Toxic Substances Control Board (www.dtsc.ca.gov/HazardousWaste/Mercury/upload/Approved-CAR-List-2.pdf) and a signature certifying that the appliance was delivered to your location.

A member of the California Energy Commission will contact you shortly, so that we can answer any questions before the rebate program launches.
