As part of the March 24, 2010, Business Meeting, the Energy Commission will consider adopting revisions to the California State Energy Efficient Appliance Rebate Program Guidelines (Guidelines). These Guidelines were developed to help implement and administer specific program areas funded by the State Energy Efficient Appliance Rebate Program (SEEARP) under the American Recovery and Reinvestment Act (ARRA) of 2009. These Guidelines were originally adopted by the Energy Commission on December 16, 2009.

At the direction of the Energy Commission's ARRA Committee, proposed changes to the Guidelines include an increase to the rebate level from \$75 to \$200 for specified refrigerators; correction to the start of the rebate offer period from March 17, 2010 to

April 22, 2010; changes to the date from December 15, 2009 to March 15, 2010 that appliances must conform to the program requirements in order to be included in the rebate program; and minor clarifying changes.

The ARRA Committee recommends the Committee Draft version of the *Guidelines* revisions be adopted by the Energy Commission. The Committee Draft version of the *Guidelines* revisions is available online at www.energy.ca.gov/stimulus/documents/index.html.
