

The purpose of the continued Conference is to review the schedule for this AFC, coordinate with the related Bureau of Land Management permit process, the exchange of testimony and other issues relating to the preparation for evidentiary hearings.

The Conference may be conducted by the Hearing Officer with or without the Committee members present. These proceedings will not be formally transcribed but an electronic recording will be kept for later review, if necessary.

- (Staff) When the revised portions of its testimony can be published, either in a single publication or in two or more discrete publications;
- (All parties) Responses to the Applicant's suggestion that the staff's analysis be based upon a "worst-case" level of environmental impacts; and
- (All parties) Identify the topic areas that are likely to require hearing time for the introduction of oral witness testimony, cross-examination, rebuttal testimony or oral argument.
