SUPPLEMENTAL IDENTIFICATION OF OPENING TESTIMONY OF STAFF

On May 9, 2010, Staff filed its *Identification of Opening Testimony* in the above-referenced proceeding. Also on May 9, 2010, Staff filed an *Errata to the Supplemental Staff Assessment Part B – Biological Resources Section* ("Errata – Biological Resources Section"). The purposes of this filing are (1) to present and file as Opening Testimony the Biological Figures 1 and 2, which were attached to the Errata – Biological Resources Section and (2) to inform the Application for Certification Committee ("Committee") and parties that Staff anticipates filing an additional errata to the Air Quality Section of the Supplemental Staff Assessment – Part B ("SSA – Part B").

Figures 1 and 2 of the Biological Resources Section attached to the Errata – Biological Resources Section will supersede and replace only Figures 1 and 2 of the Biological Resources Section of the SSA – Part B. These new Figures 1 and 2 are now being filed as part of Staff's Opening Testimony. All parties were served with a copy of the Errata – Biological Resources Section on June 9, 2010. The table identifying the chapters and technical sections of each of these documents that will comprise Staff's Opening Testimony has been updated below to reflect these new items of Staff's Opening Testimony.

Staff would like to inform the Committee and parties that it anticipates filing an errata to

the Air Quality Section of the SSA – Part B. On May 24, 2010, the Mojave Desert Air Quality

Management District (MDAQMD) informed Staff that the MDAQMD would be publishing a

revised Final Determination of Compliance ("FDOC") shortly to reflect District-wide changes to

heat-transfer fluid fugitive emissions monitoring and to incorporate recent permit conditions for

above-ground gasoline storage tanks. Staff has not yet received a copy of the revised FDOC.

Staff will file revised Opening Testimony as quickly as possible.
