

On behalf of the City of Palmdale ("Applicant") for the Palmdale Hybrid Power Plant Project (08-AFC-9) ("PHPP") and pursuant to the Committee Schedule issued on October 23, 2009, we hereby submit this Status Report No. 13.

I. Applicant Has Addressed All Issues And Informational Requests Identified By Staff In The PSA And PSA Workshops

Volume 1 of the PHPP Preliminary Staff Assessment (PSA) was issued on December 23, 2009 and Volume 2 was issued on February 9, 2010 by the California Energy Commission (CEC). A PSA Workshop was held to discuss the PSA (Volumes 1 and 2) on February 11, 2010 and another PSA Workshop focusing on Biological Resources was held on March 16, 2010. As of its last submittal on May 12, 2010, Applicant has addressed all issues and informational requests identified by Staff in the PSA or during the PSA Workshops, as described in more detail in Applicant's Status Report No. 12.

II. Applicant Anticipates Final Staff Assessment (FSA) Issuance In Near Future

Since the Applicant has responded to all data requests related to the PSA and PSA Workshops as of May 12, 2010, Applicant anticipates that the FSA will be published in the near future.

The Revised Committee Schedule (dated October 23, 2009) establishes an FSA publication date within 30-40 days after Staff receives information identified in the PSA, which results in the following timeline:
