On behalf of San Joaquin Solar 1 LLC and San Joaquin Solar 2 LLC, I am writing to withdraw the application for certification of the Joaquin Solar 1&2 Hybrid Project

We were not able at this time to resolve some of our issues regarding project economics and biomass supply amongst other things. We greatly appreciate the effort you put into processing this application.

I hereby attest, under penalty of perjury, that the contents of this Notice of Withdrawal are truthful and accurate to the best of my knowledge. San Joaquin Solar 1 LLC and San Joaquin Solar 2 LLC are special purpose entities, each created to develop, construct, own, and operate one solar thermal hybrid power generation plant and supply the electrical output to PG&E under a 20-year power purchase agreement. Martifer Renewables Solar Thermal LLC is the parent of both San Joaquin Solar 1 LLC and San Joaquin Solar 2 LLC.
