

Subject: Mariposa Energy Project (09-AFC-3) Project Status Report #7

Pursuant to the Committee Scheduling Order dated October 30, 2009, the following is staff's Status Report #7 for the proposed Mariposa Energy Project (MEP). This is an update for activities that have occurred since the previous Status Report on May 28, 2010.

Outstanding Data Responses

The applicant provided responses to comments from: Energy Commission staff, Contra Costa County Airport Land Use Commission, Keith Freitas - Contra Costa County Director of Airports and Hal Yeager - Contra Costa County Airport Land Use Commissioner on June 18, 2010.

Staff held a data response workshop on June 30, 2010 to discuss the information and clarify any technical questions staff had.

Bay Area Air Quality Management District

The applicant is currently working with the Bay Area Air Quality Management District (BAAQMD) in regard to appropriate current air district standards and the information to prepare the Preliminary Determination of Compliance (PDOC). The delay of the PDOC is creating a delay in the preparation of the Air Quality analysis.

Project Schedule

The project schedule is dependent upon the applicant providing complete data responses and the PDOC being issued by the air district. Staff is unable to commit to a schedule at this time without assurances on when the PDOC will be issued. Once staff, knows when the PDOC will be issued, we will propose a modified schedule.

Staff will continue to keep the Committee apprised of current work products and critical timelines, and a project status report will be prepared for August 1, 2010.
