### **Purpose of the Additional Evidentiary Hearing**

The Committee Ordered the additional Evidentiary Hearing at the July 1, 2010 Prehearing Conference in order to give the parties an opportunity to respond to testimony related to Cultural Resources and Socioeconomics which was not included in the June 11, 2010 publication of the Revised Staff Assessment. Upon a showing of good cause by any party or at the direction of the Presiding Member, the Committee

may allow parties to submit evidence on other subject areas. Motions to submit evidence on subject areas other than Cultural Resources and Socioeconomics will be heard at the conclusion of the July 12 through July 13, 2010 Evidentiary Hearing. All evidence must conform to the requirements contained in the Revised Notice of Prehearing Conference and Evidentiary Hearings issued on April 1, 2010.

Local, state, and federal governmental agencies may participate at the Evidentiary Hearing, as necessary. (Cal. Code Regs., tit. 20, § 1714.5.) Elected officials and members of the public may present public comments at these events and/or submit written comments to the Energy Commission's Docket Unit.
