Joint Committee Workshop on Clean Energy Jobs and Workforce Development under the American Recovery and Reinvestment Act

The California Energy Commission's Integrated Energy Policy Report (IEPR) and Federal Stimulus Program (Ad Hoc) Committees will conduct a joint workshop to discuss the increasing demand in California for employees with skills in clean energy technology — including energy and water efficiency, renewable energy, and clean transportation — and to explore the various efforts underway throughout the state to expand training and employment opportunities in these fields. Millions of federal stimulus and state dollars are being invested to develop a clean energy workforce for California, and this workshop will provide information from researchers as well as training organizations and agencies that are using those funds to implement cutting-edge clean energy jobs programs.

Chairman Karen Douglas is the Presiding Member of both Committees; Commissioner Jeffrey D. Byron is the Associate Member of the IEPR Committee, and Commissioner Anthony Eggert is the Associate Member of the Federal Stimulus Program (Ad Hoc) Committee. Other Commissioners may attend and participate in this workshop. Commissioners and staff from the California Public Utilities Commission may also attend and participate.

Purpose

The workshop will provide an overview and any results of the extensive efforts underway in California on clean energy jobs and workforce development. The goal is to share information and solicit input on improvements to maximize the benefits from projects advancing a clean energy workforce.

Information gained from this workshop will be incorporated into the 2010 Integrated Energy Policy Report Update required by Senate Bill 1389 (Bowen and Sher, Chapter 568, Statutes of 2002). The 2010 IEPR Update focus is on how projects in California receiving ARRA awards are creating economic benefits and new jobs, reducing California's dependence on imported energy, and increasing California's competitiveness in national and international energy markets. The report will also concentrate on how ARRA-related efforts can provide the foundation for long-term achievement of California's energy and environmental policy goals and help the state transform its energy production and use in a way that will provide lasting and sustainable economic, energy, and environmental benefits.

The Committees encourage oral comments from interested stakeholders and the public on any of the presentations or discussions at the workshop.

Background

The American Recovery and Reinvestment Act of 2009 (ARRA) was signed into law on February 17, 2010. ARRA was a direct response to the recession, with job creation and preservation as one of its primary goals.

The clean energy economy and its contribution to job creation is an essential element of the nation's economic recovery. According to a report by the Pew Charitable Trusts, between 1998 and 2007 clean energy jobs nationwide grew more than two and a half times faster than overall jobs. Similarly, a report by Next10 found that employment in green business in California increased by 36 percent between 1995 and 2008, and between 2007 and 2008 green jobs grew 5 percent while total jobs dropped 1 percent.

California continues to lead the nation in moving toward a clean energy economy by implementing vehicle and building efficiency standards, developing renewable energy resources, and reducing greenhouse gas emissions. However, this leadership can only

be maintained with a well-trained workforce that can support the advancement of the state's energy and environmental policies.

California is also a leader in clean energy workforce development with its Green Workforce Initiative, which is executed by a partnership between the California Workforce Investment Board, the Energy Commission, the Employment Training Panel, the Labor and Workforce Development Agency, and a host of partner agencies. The initiative includes three funding opportunities: the Clean Energy Workforce Training Program (CEWTP), the State Energy Sector Partnership and Training Grants, and Regional Industry Clusters of Opportunity.

 In August 2009, Governor Schwarzenegger announced the CEWTP, the largest state-sponsored clean energy jobs training program in the nation. CEWTP is a partnership between the Green Collar Jobs Council, the Labor and Workforce Development Agency, the Energy Commission, the Employment Development Department, the Employment Training Panel, and the California Workforce Investment Board.

CEWTP has awarded \$27 million to 34 local workforce investment boards and community colleges who will lead regional workforce training partnerships throughout California to train approximately 5,600 workers for jobs in the clean energy field. An additional \$4.5 million was awarded to 14 grantees comprising community colleges, labor organizations, and businesses. These grantees will train an additional 3,400. The program focuses on occupations in energy efficiency, water efficiency, renewable energy (distributed generation and utility-scale), and alternative and renewable transportation technologies. Funding will come from ARRA and the federal Workforce Investment Act as well as the Energy Commission's Alternative and Renewable Fuel and Vehicle Technology Program. The Energy Commission is working closely with the Green Collar Jobs Council, which is developing a statewide green workforce development plan for the future, to ensure that the CEWTP is sustainable into the future.

- The California Workforce Investment Board has been awarded \$6 million in funding from the Department of Labor's Employment and Training Administration under the State Energy Sector Partnership grant. This funding will support six regional teams that will develop training programs in emerging energy efficiency and renewable energy industries. This work is complementary to the existing work of California's Green Collar Jobs Council, established in September 2008 and tasked with understanding the current and future workforce needs of the green/clean economy and developing a strategy to prepare California's workforce to meet the needs of businesses supporting the economy.
- The **Regional Industry Clusters of Opportunity Grant** solicitation was developed jointly by the California Workforce Investment board, the Energy Commission, and

the California Economic Strategy Panel. These grants are funded by \$2.2 million from ARRA, the Energy Commission's Alternative and Renewable Fuel and Vehicle Technology Program, and the Workforce Investment Act. These grants will help Local Workforce Investment Boards to identify growing industries, undertake strategic planning, and leverage public and private resources.

Another workforce effort in California is the Centers of Excellence, an initiative by the California Community Colleges Economic and Workforce Development program. There are 10 Centers located throughout California to help community colleges better understand the needs of the state's regional economies. This data assures that community colleges' curricula produce workers whose skills match the needs of California's businesses. The Centers of Excellence initiative includes a clean energy workforce component.
