

Thank you and your staff for participating in the 1 July meeting at Edwards AFB regarding concerns about potential reflections (otherwise referred to as glimmer/glint) associated with the Palmdale Hybrid Power Plant (PHPP). SUBJECT: Palmdale Hybrid Power Plant – Response to the City of Palmdale letter, 23 Jun 10

1. Thank you and your staff for participating in the 1 July meeting at Edwards AFB regarding concerns about potential reflections (otherwise referred to as glimmer/glint) associated with the Palmdale Hybrid Power Plant (PHPP). I assure you that my staff and I, as well our parent organization, the Acquisition Environmental and Industrial Facilities Division (ASC/WNV) of the Aeronautical Systems Center at Wright-Patterson AFB, understand your concerns and the need to swiftly reach closure. Let me also assure you that we are committed to continuing a cooperative and open relationship with the City and to promptly resolving all concerns that have arisen to date, as well as any that might conceivably arise in the future. To the best of my knowledge, at this time all other known concerns have in fact been resolved and we are working to close the reflection concern as quickly as possible as well.

2. As noted during the 1 Jul 10 meeting with Maj Gen David Eichhorn (AFFTC/CC) and his staff, the City of Palmdale, ASC/WNV, ASC Detachment 1, and others, that under some circumstances substantial reflections can be observed during flight paths similar to those used for landing approaches to runway 7/25 at Air Force Plant (AFP) 42. Fortunately, and as stated during the meeting, these reflections are not widespread and can be observed only with specific combinations of sun azimuth and elevation, aircraft approach geometry and mirror position. AFFTC suggested that the Aeronautical Systems Center (ASC) further investigate these specific combinations through some type of modeling/simulation and develop operating procedures or design inputs to mitigate hazards, if any. Please note that we no longer see a need for flight testing at this time and hereby withdraw our 9 June request that the City fund such test flights.

3. Mr. Richard Harstad, Director, ASC/WNV took the action to drive for closure by the end of this month. We appreciate the recent info that was sent to us from your consultant, Inland Energy, Inc. and look forward to working with them and your office on our modeling activity. We understand the City's urgency in quickly closing this issue, which has been highlighted by the California Energy Commission as one of the obstacles to the final staff assessment (FSA) permitting process and we greatly appreciate the City of Palmdale's commitment to assisting in mitigating any hazards that this modeling approach may find.
