Dear Mr. Meyer:

On July 21, 2010, the Imperial County Fire Department (ICFD) submitted a letter (see attached) regarding the above project pertaining to potential costs for mitigation of impacts resulting from the Imperial Valley Solar development. At the time that letter was sent, we had not had the opportunity to fully review the CEC Staff Rebuttal Testimony pertaining to Worker Safety/Fire Protection.

Since then, we have more closely read the staff report and have concluded that it may contain some inaccurate or misleading statements. We apologize for any misunderstandings that may have occurred based on our earlier letter, and we hope to hereby clarify our position.

We agree with that section of the report which states it may be necessary to "…prepare an independent fire needs assessment and a fire risk assessment for the IVS project…" (P. 56). Until such an assessment is completed and fully reviewed by ICFD, it would be difficult for us to accurately determine the proper mitigation measures necessary to address the impacts from this project. Therefore, we are not supportive of the mitigation option identified in the report which quantifies the dollar amounts to be paid by Tessera (P. 59). We hereby request that CEC adopt the alternative found on P. 57 of the report, "…that requires the IVS power plant to…negotiate a mitigation fee agreement with the ICFD…" As further stated in the report said mitigation agreement should cover up-front capital costs, facilities requirements and staffing needs.

We look forward to working with CEC and Tessera to finalize a mitigation agreement at the earliest possible date. We would request that we be provided with specific details and plans for the project, in their final form, as soon as they are available.
