A quick note to everyone. I just spoke with Noel Casil at URS regarding the required intersection improvements.

Noel will check with Kern County to determine if the required roadway improvements at (1) the intersection of Dairy Road/Stockdale Highway (separate left-turn lane on the westbound approach of Stockdale Highway, and a separate right-turn lane on the northbound approach of Dairy Road) and (2) the intersection of Dairy Road/Adohr Road (reconstruct the intersection to accommodate the turning radius needed by large trucks) can be accommodated with the existing ROW width or will require construction outside the existing ROW.

Noel indicated to me that he will be at a conference between July 28 and August 1, with limited availability during those dates. Hopefully he can get the necessary information to make his determination prior to his departure. Please contact me with any questions. Thanks, Scott
