Purpose

The Energy Commission Staff is currently analyzing Hydrogen Energy International's (HEI) Revised Application for Certification (AFC) for the proposed development of HECA, and preparing the Preliminary Staff Assessment (PSA). The purpose of the workshop is to discuss the draft MRV Plan and to learn more about the operation and management of the CO₂ EOR Project that is proposed by OEHI. The main objective of the CO₂ EOR

Project would be to use CO₂ produced by the HECA project to extend the life of OEHI's existing enhanced oil recovery program in an area within the Elk Hills Unit (EHU). It is expected that a large portion of the CO₂ used in the EOR will be permanently sequestered within the EHU. The MRV Plan is one means of evaluating the success of this project.

Background

On May 28, 2009, HEI submitted a Revised AFC to the California Energy Commission proposing to construct and operate an electrical generating plant near the unincorporated community of Tupman, in western Kern County, California. HECA would be an integrated gasification combined cycle (IGCC), 250-megawatt (MW) power generation facility. The gasification block, which produces hydrogen syngas, would also capture carbon from the raw syngas at steady-state operation that would be transported to the Elk Hills Field for CO₂ EOR.

The proposed project would be located on a 473-acre site located approximately 7 miles west of the outermost edge of the city of Bakersfield and 1.5 miles northwest of Tupman. The site would be located near a hydrocarbon-producing area known as the Elk Hills Field, and is currently used primarily for agricultural purposes.
