During the July 27, 2010 Evidentiary Hearing for the IVS Project, the parties raised concerns over the changes in the conditions of certification in the Biological Resources section of the Supplemental Staff Assessment published on July 7, 2010. Since many of the conditions were modified in consultation with other resources and regulatory agencies, and since the only additional hearing is scheduled for August 16, the Presiding Committee announced at the hearings that they were waiving the normal notice period to allow the parties to attempt to resolve the issues prior to the hearing.

During the August 5, 2010 Evidentiary Hearing for the Calico Solar Project, the parties raised concerns over the changes in the conditions of certification in the Biological Resources section of the Supplemental Staff Assessment published on July 21, 2010. Since many of the conditions were modified in consultation with other resources and regulatory agencies, and since the only additional hearing is scheduled for August 18, the Presiding Committee announced at the hearings that they were waiving the normal notice period in order to allow the parties to attempt to resolve the issues prior to the hearing.
