PALEN SOLAR I, LLC'S ISSUE STATEMENT FOR THE SEPTEMBER 9, 2010, STATUS CONFERENCE

Palen Solar I, LLC (PSI) files this status report in accordance with the Notice of Mandatory Status Conference dated August 30, 1010. PSI remains concerned that it has substantially reconfigured the Palen Solar Power Project (PSPP) to address Staff's concerns, with which it had strong technical disagreement. PSI provided these reconfigurations at considerable expense and loss of generating efficiencies because Staff assured it that it could still support an analysis that would ensure a Decision by the end of 2010. As PSI has explained at REAT meetings and in this forum, a Decision by the end of 2010 could enable it to expend funds in order to qualify for the "Safe Harbor" provision allowing it to qualify for ARRA funding. Staff is incorrect in its Status Report alleging that PSI has ever "given up" on ARRA funding. PSI did state that with the reconfigurations to accommodate Staff that it would not be able to start construction in 2010. PSI has essentially been punished by seeking an accommodation with Staff by reconfiguring the project to avoid sand transport issues.

It is still possible for the Commission to issue a Decision by the end of the year which would meet PSI's current objectives. PSI offers the following schedule which accommodates The Center for Biological Diversity's (CBD) scheduling conflicts and Staff's slip of the RSA, Part 2 to September 16, 2010.
