### Notice of Availability Related to the

### Revised Staff Assessment for the proposed

Palen Solar Power Project (09-AFC-7)

The California Energy Commission (Energy Commission) staff filed Part I of a Revised Staff Assessment (RSA) on September 1, 2010 and Part II of the RSA on September 16, 2010. This notice is for both Part I and Part II of the RSA for the proposed Palen Solar Power Project.

### TO: MEMBERS OF THE PUBLIC

This notice is to inform you of the availability of the RSA for the proposed Palen Solar Power Project (PSPP). The RSA contains the Energy Commission staff's environmental, public health and engineering evaluation of the proposed PSPP.

The RSA will serve as the Energy Commission staff's testimony during the Commission's evidentiary hearings. The Energy Commission Committee assigned to the PSPP proceedings will consider and weigh the testimony, comments, and recommendations of all interested parties, including Energy Commission staff, the applicant, intervenors, public, and other local, state, and federal agencies, before issuing the Presiding Member's Proposed Decision (PMPD) for consideration by the full Energy Commission. The public, intervenors, local, state and federal agencies are encouraged to participate in these hearings that will be noticed separately.

### **Background**

On August 24, 2009, the California Energy Commission received an Application For Certification (AFC) from Palen Solar I¹ to construct and operate the Palen Solar Power Project in Riverside County. On October 26, 2009, a Supplement to the AFC was received and evaluated by staff. Subsequently, at the Energy Commission's November 18, 2009 Business Meeting, the AFC was deemed complete, beginning staff's analysis of the proposed project.

To facilitate the permitting of the Palen Solar Power Project (PSPP), the Applicant is requesting that the CEC issue one License to a Project- specific company. The company for PSPP is Palen Solar I, LLC a wholly owned subsidiary of Solar Millennium and the single Applicant for the PSPP.

### **Project Description**

The PSPP is a concentrated solar thermal electric generating facility with two adjacent, independent, and identical units of 250 megawatt (MW) nominal capacity each for a total nominal capacity of 500 MW. The project is proposed to be located in the Southern California inland desert, approximately 10 miles east of the small community of Desert Center, in eastern Riverside County, California; approximately halfway between the cities of Indio and Blythe; and about three miles east of the southeast end of Joshua Tree National Park. The applicants are seeking a right-of-way grant for approximately 5,200 acres of lands owned by the federal government and administrated by the Bureau of Land Management (BLM). Construction and operation of the project would disturb a total of about 2,970 acres.

The project would generate electric power through solar energy using parabolic trough technology. The project would use dry cooling technology. Pipelines supplying water would be routed from on-site wells to water treatment units. Water would be used principally for solar mirror washing, feedwater makeup, onsite domestic use, cooling of auxiliary equipment, and firewater supply. Total water consumption for the project is estimated at 300 acre-feet per year.

If approved, project construction would begin in 2011, with commercial operation commencing in mid 2013.

### **Energy Commission Review Process**

The Energy Commission is responsible for reviewing and ultimately approving or denying all applications to construct and operate thermal electric power plants, 50 MW and greater, in California. The Energy Commission's facility certification process carefully examines public health and safety, environmental impacts and engineering aspects of proposed power plants and all related facilities such as electric transmission lines and natural gas and water pipelines. The Energy Commission is the lead agency under CEQA.

Because the project is proposed to be developed on land administered by the Bureau of Land Management (BLM), the BLM is reviewing the project as the lead agency under the National Environmental Policy Act (NEPA). The initial environmental review document for Palen (Staff Assessment/Draft Environmental Impact Study, SA/DEIS) was published jointly by the Energy Commission and the BLM on March 18, 2010. The final environmental review documents for this project will be published separately (the RSA for the Energy Commission staff and a Final EIS for the BLM).
