We write to encourage your favorable consideration and quick approval of the Mariposa Energy Project proposed by Diamond Generating Corporation ("DGC"). Located in an unincorporated area within Alameda County, but near Contra Costa and San Joaquin Counties, this Bay Area energy project is important to our local electrical grid reinforcement and fit into overall regional energy needs, will play an important role as we integrate more renewable power into the grid, and offers regional investment and economic benefits.

As California embraces the very aggressive targets to reduce emissions set forth in AB 32 and by Executive Orders, we understand and appreciate the need to enhance our use of renewable energy sources. Mariposa is a necessary component of the strategy to bring us to this goal. Mariposa will be a natural gas-fired, simple cycle electrical generating facility with a capacity of only 200 megawatts.
