

NOTICE OF RECEIPT

PETITION TO TERMINATE APPROVAL TO CONSTRUCT PERMIT
THE ENERGY COMMISSION DECISION for the
SAN FRANISCO ELETRIC RELIABLITY PROJECT (04-AFC-1C)

On June 28, 2010, the City of San Francisco Public Utilities Commission filed a petition with the California Energy Commission requesting the Approval to Construct Permit be canceled for the San Francisco Electric Reliability Project. The 145-megawatt project was certified by the Energy Commission on October 3, 2006, and was never constructed. If built, the facility would have been located on a 4-acre site owned by City and County of San Francisco (CCSF) that lies south of 25th Street and approximately 700 feet east of Illinois Street.

DESCRIPTION OF PETITION

The petition request would cancel the Approval to Construct Permit and the project would not be built.

ENERGY COMMISSION AMENDMENT REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality, public health, and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and if the project, as modified, will remain in compliance with applicable laws, ordinances, regulations, and standards (Title 20, Calif. Code of Regulations, section 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving or denying the amendment proposal will be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the project site who may want to participate in the amendment process.
