

# CHAIRMAN'S ORDERS ON (1) FILING OF NOTICE OF DECISION AND (2) RECONSIDERATION OF EFFECTIVE DATE OF DECISION

The Energy Commission approved the Calico Solar Project on October 28, 2010; the decision approving the project states that "[t]his Decision is adopted, issued, effective, and final on October 28, 2010." The Notice of Decision ("NOD") required by the California Environmental Quality Act ("CEQA") was filed on November 3, 2010. The complete final decision for the project was docketed and made publicly available on November 12, 2010.

On November 11, 2010, California Unions for Reliable Energy ("CURE", an intervenor in the proceeding) and Mr. William Perez wrote a letter to the Commission concerning the NOD and the effective date of the decision ("the CURE Letter").

Pursuant to the authority granted to the Chairman by the Warren-Alquist Act and the Commission's regulations, I make the following orders. (See Pub. Resources Code, § 25217.5.) Cal. Code Regs., tit. 20, §§ 1103, subd. (b), 1203, subds. (c), (d).)

Nothing in this document or in actions related thereto should be considered as implying or stating agreement with any factual or legal argument in the CURE Letter, or as an interpretation of any statute or regulation pertaining to effective dates, NODs, statutes of limitation, or similar matters.

1. The Executive Director shall withdraw the Notice of Decision today (November 19, 2010) or as soon as possible thereafter.

2. The CURE Letter will be treated as a Petition for Reconsideration from CURE under the Commission's regulations (see Cal. Code Regs., tit. 20, § 1720, subd. (a)), with the subject of the Petition being reconsideration of the "adopted, issued, effective, and final" date of the decision ("effective date"). (Because Mr. Perez is not a party to the Calico proceeding, he cannot petition for reconsideration. However, he is welcome to participate as a member of the public.)

3. The Commission will consider granting the Petition at the December 1, 2010, Business Meeting, and it will also consider ordering, on its own motion, reconsideration of the effective date of the decision to coincide with the date of re-filing of the NOD. The Executive Director shall notice consideration of the effective date on the agenda for the Commission's December 1, 2010 business meeting.

4. If on December 1st the Commission grants the Petition, or orders reconsideration on its motion, or both, the "subsequent hearing . . . [to] decide whether to change the decision" – i.e., to change the date to coincide with the re-filing of the NOD – shall be held immediately afterwards on December 1st. (See Cal. Code Regs., tit. 20, § 1720, subd. (c).)

5. The Executive Director shall not re-file the Notice of Decision until after the December 1, 2010, Business Meeting.

6. The provisions of the Calico decision related to its effective date are stayed (and any applicable statutes of limitations are therefore tolled) as of the date of this order, pending reconsideration. (See Cal. Code Regs., § 1720, subd. (d).)
