According to the requirements of Government Code sections 11346.8(c), 11346.8(d), 11346.9(a)(1) and 11347.1, the California Energy Commission is providing notice of changes made to the Express Terms (45-Day Language) and Initial Statement of Reasons (ISOR) which will be subject to a regulatory hearing.

The documents and information added to the rulemaking file are as follows:

- Revised Express Terms (15-Day Language) with addition of definition.
- Revised Initial Statement of Reasons with additional necessity/rationale/purpose.

Purpose

On October 22, 2010, the Energy Commission published a Notice of Proposed Action (NOPA) concerning the potential adoption of proposed regulations for the Solar Offset Program. The NOPA, ISOR and Express Terms (45-Day Language) were posted on the Energy Commission’s website on October 21, 2010. The NOPA designated December 29, 2010, as the date for consideration of adoption. The public hearing listed on the NOPA, with the Energy Commission’s Renewables Committee, will be held on December 7, 2010. Proposed 15-Day Language

On November 19, 2010, staff provided additional purpose and rationale to the ISOR (pursuant to Government Code Section 11346.2 (b)(1)). The revisions to the ISOR clarified the rationale of the proposed regulations.

Staff also added the definition of a single-family residence to the Express Terms.
