Pursuant to the Committee Scheduling Order dated October 29, 2010, the following is staff's Status Report #11 for the proposed Mariposa Energy Project (MEP).

Staff Assessment Publication

The Mariposa Energy Project Staff Assessment was published on November 8, 2010. The 30-day comment period on the Staff Assessment will last from November 9, 2010 to December 9, 2010. Staff will incorporate comments received during this period into the Supplemental Staff Assessment.

Applicant Comments

The Mariposa Applicant provided comments on the Staff Assessment on November 24, 2010. The majority of the comments were minor clarifications and requested modifications. Comments were provided on air quality, biological resources, hazardous materials, land use, noise and vibration, public health, socioeconomics, soil and water resources, traffic and transportation, transmission line safety and nuisance and visual resources.


Staff Assessment Workshop

A Staff Assessment Workshop was held in Byron on November 29, 2010. The workshop was well attended by the Mountain House Community, and the local residents actively participated. Comments at the workshop were mainly in regard to air quality impacts, airport safety concerns, public health thresholds and criteria, socioeconomic concerns and water rights / water conservation programs. Comments were also provided on project alternatives and land use.

Bay Area Air Quality Management District

The Bay Area Air Quality Management District (BAAQMD) issued the Final Determination of Compliance (FDOC) on November 24, 2010. The FDOC will be incorporated into staff's analysis for the Supplemental Staff Assessment.
