CCGS, LLC'S REQUEST FOR SCHEDULING ORDER

Contra Costa Generating Station LLC (CCGS), hereby requests the Committee update the current schedule for the Oakley Generating Station (OGS) 09-AFC-4. CCGS wishes to express its gratitude to the Committee for scheduling the upcoming status conference to discuss the importance and priority of this project. The Committee last issued a Scheduling Order for this case on November 23, 2009.

OGS is currently awaiting California Energy Commission (CEC) Staff's publication of the Preliminary Staff Assessment (PSA). Our understanding is that the only information that was outstanding for Staff to complete the PSA was the Bay Area Air Quality Management District's (BAAQMD) Preliminary Determination of Compliance (PDOC). On October 29th, 2010, the BAAQMD supplied a copy of the PDOC to the CEC Staff. The PDOC was issued publically immediately thereafter with the comment period scheduled to close on December 7, 2010.

CCGS has a Purchase and Sale Agreement with Pacific Gas & Electric Company (PG&E) for the OGS, which is scheduled to be approved by the California Public Utilities Commission (CPUC) on December 16, 2010. The OGS has broad community support, is on previously disturbed land, and will employ General Electric's new state-of-the-art Rapid Response combined-cycle technology with far lower emissions than many of those projects that have been permitted in recent years. The Rapid Response technology is highly desirable for renewables integration.

It is imperative for the OGS to begin construction in late May of 2011 in order to qualify for a current grandfathering exemption contained in the Prevention of Significant Deterioration (PSD) Tailoring Rule. Currently, because the OGS's emissions are below regulatory thresholds, it is not required to obtain a federal PSD Permit. The PDOC reflects this determination. EPA adopted the Tailoring Rule which applied PSD requirements to Greenhouse Gas Emissions, which were previously not regulated by the PSD process. The Tailoring Rule allows projects such as OGS, which prior to the Tailoring Rule were not required to obtain a PSD Permit, an exemption if the OGS has begun "actual construction" by July 1, 2011. "Actual construction" under the current EPA Guidance would require physical permanent construction of an emitting unit, such as pouring foundations. Unfortunately, contracting, engineering or grading would not constitute "actual construction" under the current guidance. The purpose of the exemption was to allow projects that had already commenced the air permitting process to avoid being caught in a regulatory change that would require it to start over. The reasoning behind the exemption was to allow sufficient time for air permitting that had begun to be completed. CCGS filed its AFC and air permit application in June, 2009.

While the Commission has been working on the renewable energy projects, the OGS has been given low priority. Now that the majority, if not all, the renewable energy projects are permitted, OGS requests the Committee give the OGS high priority status and adopt a Scheduling Order with the following dates.

December 17, 2010 On or before January 10, 2010 30 days after receipt of FDOC

Staff Publishes PSA Staff holds PSA Workshop Staff Publishes FSA

Once the PSA Workshop is completed, we request the Committee require the parties to submit status reports and proposed schedules for the remainder of the proceedings. CCGS thanks the Committee for its consideration and will be prepared to work cooperatively to achieve a Final Decision within a timeframe that would allow it to meet the definition of "actual construction" by July 1, 2011.
