**Motion to Revise Committee
Schedule Dated October 29, 2010**

Introduction

On October 29, 2010, the Committee issued a Project Scheduling Order which was based on Staff filing the Staff Assessment (SA) on 11/10/10. Each date of the schedule is based on the Staff Assessment being issued per the date of the schedule of 11/10/10 when it was docketed for the General Public or in terms of weeks. However, the Staff Assessment was served to all Parties (including Interveners) on 11/08/10. The Commission Ordered Staff to (Re: page 2) to inform all parties of any schedule delays.

Staff Supplemental Assessment Issued (SSA) 12/17/10

The Staff Supplemental Assessment (SSA) was to be issued in Week 5 with a hard date of 12/13/10 per the Commissions Schedule. The SSA was served to all parties and the General Public and docketed on 12/17/10. The SAA is late and now into week 6.

Staff Supplemental Assessment Issued (SSA) 12/17/10 Lacking

The SSA is lacking in clarity and is confusing to the General Public and Interveners. The SSA was issued as a final document and did not include a Tracking Document which should have included both strikeout and redline changes to review. The Final SSA is now a document that must be read line by line and compared to the SA to find edited changes that have been added deleted or modified. This will take an enormous amount of time to review and understand by the General Public and Interveners.

The Project Manager sent an email on 12/17/10 @ 1:34:07 with additional project data and clarifications. Staff continues to supplement data by email which is not a substitute for the SSA.

Motion to Revise Schedule

California Pilots Association (CALPILOTS) makes a motion [Cal. Code., tit. 20 §1709.7 (c).] to revise all Event Dates and Required Intervals for the Mariposa Energy Project Power Plant Commission Schedule by a minimum of 14 days or 2 weeks forward from 12/17/10 or from the date the Staff Dockets a complete and SSA with tracking changes.
