

Subject: Mariposa Energy Project (09-AFC-3) Project Status Report #13

Pursuant to the Committee Scheduling Order dated October 29, 2010, the following is staff's Status Report #13 for the proposed Mariposa Energy Project (MEP).

Staff Documents / Evidence

The Staff Assessment was published on November 8, 2010 and the Supplemental Staff Assessment was published on December 16, 2010. These two documents will comprise the majority of staff's evidence.

Staff anticipates filing an errata or providing additional information at the evidentiary hearing on Biological Resources. Staff concluded that impacts to biological resources affected by the proposed project could be mitigated below a level of significance by implementation of the proposed conditions of certification. Staff's analysis and proposed conditions of certification with US Fish and Wildlife Service (USFWS) and are expected to be consistent with the terms and conditions to be included in the final Biological Opinion.

However, because the Biological Assessment (BA) has not yet been determined to be adequate by the USFWS, modifications to staff's impact analysis and conditions of certification may be necessary if revisions to the recent draft BA result in changes that are contradictory to staff's analysis or conditions.

Project Schedule

At the request of several intervenors and in an attempt to keep the project on schedule, staff provided the Supplemental Staff Assessment (SSA) sections in a compare mode from the Staff Assessment on December 20, 2010 to everyone on the Proof of Service list and will provide it to anyone else who may want it in that format.
