Dear Mr. Abbott and Mr. O'Brien:

Solar Millennium, LLC is withdrawing its application for the Ridgecrest Solar I, LLC project effective immediately. A review of the process and staff position on the project strongly suggests success is unlikely.

The issues faced by Ridgecrest Solar are not dissimilar from the other renewable projects. Prior to the start of the approved Mohave Ground Squirrel (MGS) connectivity study, Solar Millennium, LLC undertook another review of the potential for a successful decision once the study is complete. A review of the record strongly suggests California agency's staff is unlikely to be open to a recommendation of approval (assuming the results of the study are favorable). In light of these circumstances, it would not be economically viable to continue to pursue either the study or the project.

The Desert Renewable Energy Conservation Plan (DRECP) is preparing a report in parallel with the MGS study schedule and will file its report before Ridgecrest could obtain regulatory approvals. The DCREP has identified Ridgecrest as a site to protect from development by amending the definition of eligible projects. In addition, the August 4, 2010 Status Report and other communications to the CEC Committee have persisted with formal and informal comments stating it too would prefer to preserve the Ridgecrest site, and referenced the early DCREP position.

As a result of Staff's position Solar Millennium, LLC believes project's success is unlikely. We therefore request that the AFC proceedings be terminated in accordance with Section 1709.8 of the Commission Regulations.
