On December 15, 2010, the Energy Commission approved the Application for Certification ("AFC") for the Palen Solar Power Project. (Docket No. 09-AFC-7, Order No. 10-1215-19 (Dec. 15, 2010).) On January 14, 2011, Intervenor Center for Biological Diversity filed a Petition for Reconsideration ("Petition") of that decision.

The Commission will hold a public hearing to consider whether to grant or deny the Petition at the following time and place:

Members of the public and parties to the Palen AFC proceeding may participate and offer oral and written comments at the hearing. The Commission also invites public, agency, and party written comments on the Petition in advance of the hearing.

In order to ensure that your comments are considered, all comments must be received physically or electronically at the address above by <u>noon</u> on Wednesday, February 9, 2011.

Pursuant to Section 1209 of the Commission's regulations, comments should include a title page with the title of the proceeding, the docket number, the nature of the material, and the name, address, and telephone number of the person submitting the comment. (Cal. Code Regs., tit. 20, § 1209, subd. (b).) All documents submitted physically (with no electronic copy), shall also submit twelve (12) copies with the original document to the Commissions' Docket Unit. (*Id.*, § 1209, subd. (c).)

Pursuant to Section 1210 of the Commission's regulations, comments filed by parties to the AFC proceeding must include proof of service to the proceeding's service list, which may be accomplished by e-mail. (Cal. Code Regs., tit. 20, § 1210.)

Please note that mailed comments must be physically delivered by February 9, 2011; a February 9 postmark is insufficient.

Procedural Background

Section 1720 of the Commission's regulations allows any party in a power facility certification case to file a petition for reconsideration of a decision or order, within 30 days after a determination is final. (Cal. Code Regs., tit. 20, § 1720, subd. (a).) That section also lists the required contents of such petitions and specifies deadlines for Commission action thereon. (*Id.*, § 1720, subds. (b)-(c).) The Commission must grant or deny a petition for reconsideration within 30 days of its filing. (*Id.*, § 1720, subd. (b).) If the Commission denies the petition, then the original determination stands. If

the Commission grants the petition, then it is required to hold a subsequent hearing (which may include the taking of evidence) within 90 days to consider whether to change the original determination (*Id.*, § 1720, subds. (b)-(c).)
