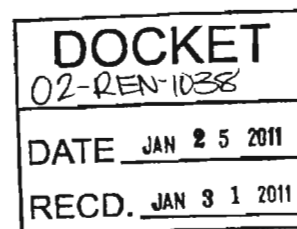

Pursuant to Title 20 California Code of Regulations section 2505(a)(4), Mount Lassen Power hereby submits this Repeated Application for Confidential Designation for the following information:

- CEC-1250E-1 Application for ERFP Funding Eligibility and all supporting attachments and materials. Specific lines and responses:
 - Line 13- Energy Contract
 - Line 19- Total funding expected from the CEC's ERFP for generation through December 31, 2011
 - Line 21- Total State tax credits received by facility
 - Line 22- Total Federal Tax credits received by facility
 - Line 23- Market value of the facility
 - Line 24- Explanation of how incentive payments will allow the facility to become cost competitive by end of the 2011 calendar year.
 - Line 26- Recent billing statement from Utility
 - Line 27- Estimate of the target price needed in order to ensure the continued operation of the facility through the application year.
 - Line 28- Estimate of the production incentive cap needed
