# NOTICE OF INFORMATIONAL HEARING AND PUBLIC SITE VISIT

On March 22, 2011, Calico Solar, LLC filed a Petition to Amend (Petition) with the California Energy Commission seeking to modify the Calico Solar Project approved and licensed by the Commission in December 2010. The approved Calico Solar Project (CSP) is located on 4,613 acres of land in an unincorporated area of San Bernardino County, California approximately 37 miles east of Barstow.

The CSP is designed as a concentrated solar thermal power plant facility with a generating capacity of 663.5 megawatts (MW). As approved, the CSP would produce power by solar collectors known as SunCatchers. Each SunCatcher consists of an approximately 38-foot diameter mirrored dish and a Stirling engine powered by hydrogen generated on site. CSP would deliver power to the Southern California Edison Pisgah Substation.

The Petition does not propose to change the size, boundary, or generating capacity of the CSP. It proposes a modification in the solar collector technology used on the site; specifically, to generate 100.5 MW of power using SunCatcher technology and 563 MW using single-axis tracker photovoltaic (PV) technology. The Petition proposes that both the SunCatchers and PV collectors will be fully integrated components of the power plant, operate from a single control room, use the same transmission interconnection system, access a common water system and road network, and depend upon the same construction and operation personnel.

**PLEASE TAKE NOTICE** that the Energy Commission will designate a Committee of two commissioners to conduct proceedings on the Petition. In the meantime, the Commission Siting Committee has scheduled a public Information Hearing and Site Visit to discuss the Petition to Amend as described below:

# Background

On March 22, 2011, the Energy Commission began its review of the Petition. During the review period, Energy Commission staff will determine whether the proposed project complies with applicable laws related to public health and safety, environmental impacts, and engineering requirements. This Informational Hearing is sponsored by the Energy Commission to inform the public about the Petition and to invite public participation in the review process.

As the lead agency under the California Environmental Quality Act (CEQA), the Energy Commission is responsible for reviewing and ultimately approving or denying all applications to construct and operate thermal electric power plants, 50 MW and greater, in California. The Energy Commission facility certification process carefully examines public health and safety, environmental impacts and engineering aspects of proposed power plants and all related facilities such as electric transmission lines and natural gas and water pipelines.

# Purpose of the Informational Hearing

This Informational Hearing provides an opportunity for members of the community in the project vicinity to obtain information, to offer comments and concerns, and to view the project site. Calico Solar, LLC will explain plans for implementing the modifications contained in the Petition to Amend and Energy Commission staff will explain the

administrative licensing process for this proposed project amendment and Staff's role in reviewing the Petition.

# **Description of Proposed Project Modifications**

The Petition is proposing to modify the approved CSP technology to include a combination of PV technology and the approved SunCatcher technology to achieve the approved 663.5 MW electrical generation. Approximately 2,140 PV tracker blocks are proposed to produce 563 MW. SunCatchers would provide the remaining 100.5 MW.

The Petition proposes phasing implementation of the project modifications. Phase 1, which is primarily located south of the BNSF railroad and comprises approximately 2,144 acres, would include the following elements:

- Main access road.
- Relocated main services complex (including temporary laydown area).
- Relocated on-site substation and shortened transmission line to the existing Southern California Edison Pisgah Substation.
- Water well located north of the railroad, and watering to the main services complex (same source and well location, with a longer waterline crossing under the railroad).
- Solar field comprised of single-axis tracking PV modules producing up to 275 MW.

Phase 2, which is located north of the railroad and comprises 2,469 acres, would include the following elements:

- Bridge constructed over the railroad.
- Continuation of the main access road north of the railroad.
- Solar field, comprised of up to 288 MW of single-axis tracking PV modules and 100.5 MW of SunCatchers, to be located toward the center of Phase 2.
- Hydrogen generation, storage, and distribution system for the SunCatchers.

All other aspects of the approved CSP will remain the same under the Petition to Amend. The engineering and environmental details of the proposed amendments are contained in the Petition to Amend. Copies of the Petition to Amend are available at the local public agencies that are involved in the review process and at the following libraries: San Bernardino County Library, Barstow and Needles Branches; Victorville Public Library; Fresno County Library; San Diego Public Library; UCLA University Research Library; Humboldt Library; San Francisco Public Library; the Energy Commission's Library in Sacramento; and the California State Library in Sacramento.

# Proposed Schedule and Issue Identification Report

To assist the parties and public in understanding the process, Staff shall file a proposed schedule for Petition review. Staff shall also file an Issue Identification Report summarizing the major issues. The proposed schedule and Staff's report shall be filed

no later than **5:00 pm on April 14, 2011**. Calico Solar, LLC shall file its response, if any, no later than **noon on April 18, 2011**.


