Dear Mr. Hoffman:

As discussed during the May 13, 2011 mandatory status conference, Calico Solar, LLC and its consultants are in the process of preparing certain studies, reports and plans required under the CEC's Conditions of Certification and/or requested by the CEC's Staff in its Data Request Set 1 dated April 15, 2011. Included as Attachment 1 to this letter is a schedule of when Calico expects to deliver these items to the CEC. The schedule is based upon information and schedules provided to Calico by its various consultants. Calico will keep the CEC apprised of any changes to the proposed schedule.

Calico understands that Staff has commenced its analysis of the Modified Project and will be able to continue its analysis as the items listed in Attachment 1 are submitted. Calico believes that the items listed in Attachment 1 are the only additional documents needed from Calico for the Staff to be able to complete its assessment.

Calico also wants to update the Committee on the Project's likely construction schedule. Calico has not conducted desert tortoise surveys this Spring and does not expect to commence project construction in 2011. Currently, Calico anticipates commencing construction of Phase 1 in the spring of 2012 by translocating desert tortoise.

Calico appreciates both the Staff and the Committee's efforts to ensure timely review and consideration of the Petition to Amend.
